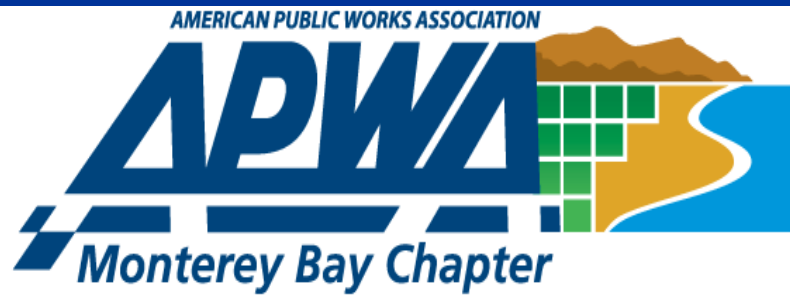

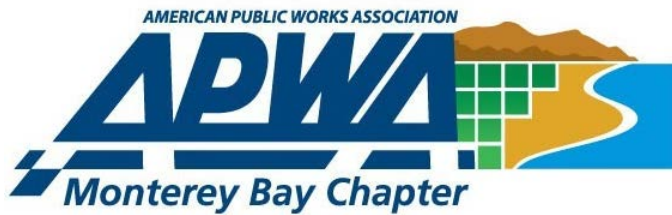
We are gathering Project and Person of the Year award applications for our Awards Night in January, nominate your projects and dedicated staff

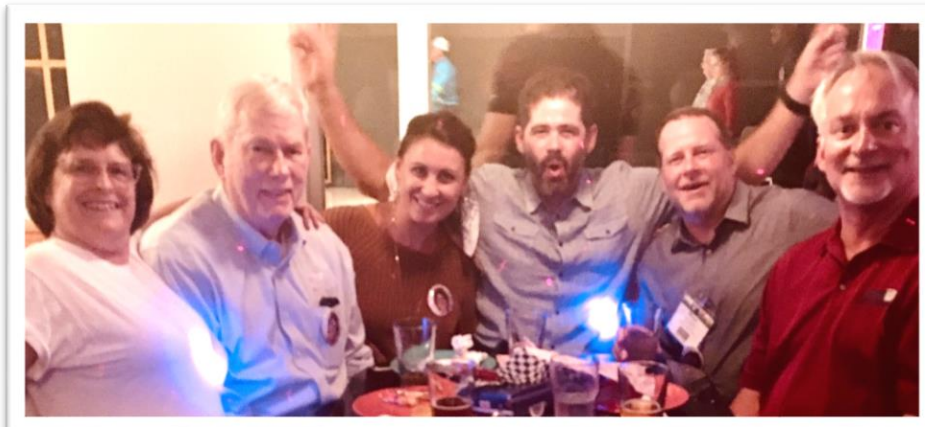

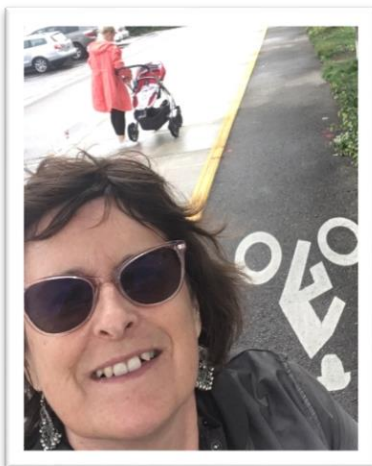
